# 6. Meeting Notes, Decisions, Issues

New additional programs were reviewed internally during the last two weeks and will be sent to external reviewers for feedback and recommendations.

The restructuring of the unfrozen Management Information Systems (MIS) program and the program offered Minor in MIS were approved by the VP&CAO and EMC and will be communicated to the office of VPSA for implementation starting from Spring 2015.

Based on the committee recommendation, the VP&CAO approved the request, submitted by the Humanities Department and discussed during the last APR&CE Committee meeting held on December 10, 2104, to remove course prerequisites for the PHIL 200 course while for the PHIL 210 course, only removal of the PHIL 100 was approved as detailed in the following table:

# Foundation program: ESP (English for Specific Purpose) Courses

Dr. Katherine from the Foundation program presented the ESP courses developed by a taskforce at the University level in order to better serve student needs in English. The current ENGL 251 "English for Communication II" course was revised into ESP course in the following areas:

- Humanities
- Social Sciences
- Business
- Law

The new version of the course is built upon knowledge and skills gained from previous courses.

The taskforce is working on identifying the needed FTE and instructional resources needed for the proposed changes and to propose a mechanism to ensure that students will take this course prior to enrolling in their junior year courses.

There was a debate over the use of an external standardized exam as the final course exam. The College of Arts and Sciences and the College of Business and Economics requested the use of an external standardized exam as part of the regular course assessment, while the College of Law, College of Sharia and Islamic Studies, College of Education, Core Curriculum Program, and the Foundation Program Department of English (FPDE) did not recommend using such test as part of the regular course assessment.

### Committee Action/Recommendation

Committee Chair requested to share the proposal with concerned colleagues at all colleges and programs for additional review and feedback. Committee members agreed to review the proposal and to send the program/college feedback to the APLOA office for aggregation of all communicated feedback. During the meeting, committee members raised a certain number of observations/concerns listed below:

- Dr. Hassan recommended that CAS maintains the external standardized exam.
- Dr. Adam raised concern about student progress in their major if they fail the exam and the course.

# • CAS: Update Prerequisite for the PUBH 314 course

The Public Health program requested to update the course prerequisites for PUBH 314 course titled "Health Education Practicum" as detailed below:

The newly suggested prerequisite PUBH 222 "Foundations of Health Education" course covers, at the appropriate level, all topics needed to prepare students for the PUBH 314 course.

## • CLAW: Update Prerequisite for the LAWC 215 course

The College of Law in collaboration with the College of Business and Economics requested to update the course prerequisites for the LAWC 215 "Business Law" as detailed below:

As per the current prerequisites for LAWC 215, students who completed ENGL 202 and thus are expected to have attained a level of proficiency higher than those who completed ENGL 111 are enable to register in the course.

### CLAW: Update Prerequisites and Registration restrictions for the LAWC 422 course

The College of Law requested to update the course prerequisites and registration restrictions for the LAWC 422 "Law of criminal procedures" as detailed below:

LAWC 422 is an advanced course and requires that student completed a minimum number of CH in law courses as well as Law criminal I and Law criminal II courses.

### • CENG: Update Prerequisites for the ELEC 471 course

The Electrical Engineering program at the College of Engineering requested to update the course prerequisites for the ELEC 471 "Selected Topics in Computer Engineering" as detailed below:

The current ELEC 364 "Microprocessors" currently listed as a prerequisite is a deactivated course previously offered as part of the 2003 plan. This course was replaced by the ELEC 366 "Embedded Systems" course in the degree requirements of concerned programs.

# Committee Action/Recommendation

Committee members recommends approval of the request

#### CPH: Increase the duration for PHAR 691 course

Due to the fact that MSc (pharm) students require an additional semester to complete their thesis work, the Master of Sciences in Pharmacy program offered at the college of Pharmacy requested to increase the course duration for the PHAR 691 "MSc (Pharm) Thesis" from one semester to two semesters. Students will get a "CC" grade at the end of the Fall semester and will be assigned a grade at the end of the first semester that will replace the CC grade assigned at the end of the next semester.

Committee chair indicated that based on VPSA feedback, implementation of the requested change in banner will require an update of the number of contact hours for the course from 5 CH to "0 to 5 CH".

It is also to be noted that Qatar University is working on revising all Thesis courses in order to have a common and clear rules regarding the grading, the duration, the designation and the implementation in Banner for all Thesis courses.

# Committee Action/Recommendation

Committee members recommends approval of the request

#### • CPH: Adding new course "Drug in Sport"

The pharmacy program requested to offer a new elective course "Drugs in Sport" for the following reasons:

- Allow opportunities for students to choose from a number of offered elective course instead of being forced to take specific courses.
- Address an important and relevant subject matter: Safe and effective use of medications in sport. This is especially important as Qatar is playing a leading role in promoting sport in the region and worldwide.
- Provide a high quality elective course with contributions from national and international experts in the subject area (Anti-doping lab in Qatar ADL-Q, Qatar Anti-doping Commission QADC, Aspetar, Liverpool John Moore University, etc.)
- Non-Pharmacy students may find interest in taking this elective course especially those in health sciences, sports sciences and medicine.

The College has conducted a survey among students regarding this course and also initiated a research paper.

#### Committee Action/ Recommendation

Committee members recommends **conditional approval of the request** with the following observations :

- The program is encouraged to consult with the Sport science program and the law program. Study the opportunity for co-teaching where faculty from the Sport Science or law programs may be involved.
- Course content and program learning outcomes should be revised.

# • CAS-CSIS-CENG: Update the letter Grade of Thesis courses – graduate programs

The College of Arts and Sciences, the College of Sharia and Islamic Studies and the College of Engineering requested to change the grade mode for all Thesis courses from "Letter grade" to "Pass/Fail".

In addition, programs requested the inclusion of variable CH for thesis and dissertation with 0 CH assigned to defense.

#### Committee Action/Recommendation

Committee members recommends **conditional approval of the request** with the following observations:

- AVP for graduate programs should consider adding "Pass with distinction" in addition to "Pass/Fail".
- All programs are encouraged to merge Thesis course I and II (when applicable) before implementation the new grade mode.
- Feedback from Student Affairs on the feasibility of implementing the request in Banner is a prerequisite for approving the request.

# CAS: Establishment of a new Department of Foreign Languages

Dr. Steven briefly presented the proposal of establishing a new department of Foreign Languages at the College of Arts and Sciences. All existing "languages courses" will be offered under this department in addition to offering new courses such as Korean and Chinese Languages. The full proposal will be communicated to Committee members for feedback and recommendations.

# • CENG: Restructuring of the College Requirements Unit (CRU)

Dr. Mahmoud presented the proposal submitted by the College of Engineering to restructure the existing College Requirement Unit (CRU) which is responsible for coordinating courses of the General Engineering Program, into a Department of Technology Innovation and Engineering Education (TIEE) which will focus on Multidisciplinary Technology Innovation, Design, and Engineering Education.

The proposal was motivated by internal and external drivers and built upon existing assets at CENG, and will be conducted with Zero cost through re-allocation of internal resources and gradual attraction of needed expertise over the next 4-5 years.

#### Committee Action/Recommendation

While committee members welcomed the proposal and were in favor of recommending approval, it was agreed that the proposal be forwarded to all members for further review and feedback.

### Additional Topic:

### • Financial Budget

The committee chair informed members that the government is adopting a new fiscal year to be in line with the calendar year and thus the timeline for budget requests and approval has changes. As assessment and planning are linked to budget, the committee will soon need to revise the timeline for some of the processes related to committee work including the Academic program review process to meet the new budget timeline. Further details on the new budget timeline will be provided once available.
